Ordered that Jeph Parker, J. and Darden and John Murphy or any two of them examine State and settle the accounts the administration of the Estate of Robert Johnson dead and report to the Court.

William James orphan of Anna James dead this day and choice of James Fee for his guardian whereupon the said James Fee together with John Marguerat his security entered into a bond acknowledged a bond in the sum of Two thousand dollars conditioned as the law directs.

Ordered that John Thomas, George Guley, John Wick, John Rochelle or any two of them let to the lowest and best rebuilding of the Cypress bridge after giving reasonable public notice of the time and place of letting the same, that they require a bond from the undertaker conditioned for the faithful performance of the undertaking and when complete, that they or such of them as may see fit make a report thereof to the Court.

Ordered that Edward Rees, Lewis Fort and Nathaniel let to the lowest and best rebuilding of the bridge over the river after giving reasonable public notice of the time and place of letting the same, that they require some security for the faithful performance of the undertaking and when complete that they report to the Court.

Ordered that Henry Briggs Robert or any two of them, let to the lowest and best rebuilding of the bridge after giving reasonable public notice of the time and place of letting the same, that they require a bond conditioned for the faithful performance of the undertaking and when complete that they report thereof to the Court. James Beale is by the Court appointed as the road near John Rochelle to allow of the road when required and it is ordered that the usual notice thereon be given and the said road when required.

Betsy Turner was this day set to the Court to whose custody she was heretofore committed for destroying her infant child on or about the 1st of January for her examination not having been sworn and examined on behalf of the State.
