

Ordered that Master Commissioner Cobb do examine State and settle an Account Current of the Administration of the Estates of Aaron Sharpe dec^d and James Miller dec^d and also the guardian account of said James Miller as Guardian of Thomas & Samuel Hilditch and Polly & Elanah and make report thereof to Court.

Ordered that Master Commissioner Cobb do examine State and settle an Account Current of the Administration on the Estates of William Deale dec^d and Nancy Mills dec^d and make report thereof to Court.

Ordered that Master Commissioner Cobb do examine State and settle an Account Current of Simon Murfree's Guardianship of John & Lydia Deale & James Powell and make report to Court.

The last Will and Testament of Rachel Williamson deceased was proved by the oath of Benjamin White a witness thereto.

Mary Thomas orphan of Henry Thomas with the approbation of the Court made choice of John Thomas for her Guardian and thereupon the said John Thomas with James Rockelle, George Gurley and John Barnes his securities entered into and acknowledged a bond in the penalty ten thousand dollars conditioned as the Law directs.

Certificate is granted them for obtaining a probate of the said Will in due form.

Ordered that Jacob Barnes, William Bryant, Isaac Everett and Benjamin Barnes or any three of them being first duly sworn before a Justice of the Peace for that purpose do appraise all the personal Estate so then possessed of Samuel Mayet dec^d & return such appraisement under their hands to Court.
