Whereupon the said Samuel Blunt appeared in Court and acknowledged service of the summons and refused to give the said Kitchin administrator as aforesaid counter security and thereupon on the motion of Benjamin Cobb who made oath and together with George Hens, and Samuel Hens his securities entered into bond in the penalty of thirty thousand dollars conditioned as the Law directs, Certificate is granted the said Benjamin Cobb for obtaining letters of administration de bono non on the estate of the said Joshua Fort deceased in due form.
