

Exam. James for returning letters of administration on the Estate of Amos Blake dec'd in due form -

Ordered that Johnson Pope, John Davis, Jason Rowe and Thomas Clifton or any three of them being first duly sworn before a Justice of the Peace for that purpose do view and appraise all the personal Estate to them procured of Amos Blake deceased and return such appraisement under their hands to Court -

The Court doth assign Temperance Vaughan Guardian to Polley, Holloy, James Pegg & Emily Vaughan orphans of Henry Vaughan deceased, and thereupon the said Temperance with Frederick Lott and Jeph Baranus her Sureties entered into and acknowledged a bond in the penalty three thousand dollars conditioned as the Law directs -

The Court doth assign Lewis N Branch Guardian to George Washington orphan of Thomas Washington deceased and thereupon the said Lewis N Branch with William Hornsack & Benjamin Barank his Sureties entered into and acknowledged a bond in the penalty of one thousand dollars conditioned as the Law directs -

On the motion of Lewis Harris who made oath and together with George Iny his Security entered into and acknowledged a bond in the penalty of five hundred dollars with condition according to Law certificate is granted the said Lewis Harris for obtaining letters of administration on the estate of Burwell Westbrook deceased in due form -

Ordered That Arthur Williamson, Littleton Williamson, Thomas Williamson and John Iny or any three of them being first duly sworn before a Justice of the Peace for that purpose do appraise all the personal Estate to them procured of Burwell Westbrook dec'd and return such appraisement under their hands to Court -

Clairborne Scott who stands bound by a recognizance for his appearance here this day, to answer the Complaint of _____ against him for a breach of the Peace this day, and Clairborne Scott being appeared accordingly, and thereupon the Court and accordingly orders that the said Clairborne Scott give security for his keeping the Peace for the term of twelve months from this day that is to say the said Clairborne Scott in the sum of one hundred dollars with two Sureties in the like sum of fifty dollars each, Whereupon the said Clairborne Scott with Drury Waller and Levi Waller his Sureties here in Court acknowledged themselves to be indebted to Thomas M Randolph Esq Governor or Chief Magistrate of the Commonwealth of Virginia, the said Clairborne Scott in the sum of one hundred dollars and the said Drury Waller and Levi Waller in the sum of fifty dollars each of their respective goods and chattels Lands and Tenements to be levied and to our said Governor and his Successors for the use of the Commonwealth and under. But upon this condition of the said Clairborne Scott shall keep the Peace and be of good behavior towards all the citizens of the Commonwealth for the term of twelve months as aforesaid, and especially towards the said _____ then this recognizance to be void -
