

according to the Act of Assembly and the rules of this Court and it appearing to the satisfaction of the Court that he is not an inhabitant of this Commonwealth On the motion of the plaintiff by his Attorney it is ordered that the said defendant do appear here and answer the plaintiff's bill on the third Monday in April next and that a copy of this order be forthwith inserted in some newspaper published in the Town of Petersburg for two months successively and posted at the front door of the Courthouse of this County.

Henry Bittle who is charged on oath by Nancy Warham with being the father of her bastard child, and stands bound by a recognizance with Joseph Rice Sr. his sons, entered into before a Justice of the Peace for this County, to appear here and abide and perform such order as the Court should make concerning the same, appeared accordingly. Whereupon the said Nancy Warham being sworn and examined and the said Henry Bittle fully heard, this Court upon the whole circumstances of the case doth adjudge the said Henry Bittle to be the father of the said bastard child, and that the said child is likely to become chargeable to this County. Therefore it is ordered that the said Henry Bittle be charged with the annual payment of twenty dollars to the Overseers of the Poor of the said County for the space of six years in case the said child shall live so long, and that the said Henry Bittle pay the same to them accordingly at the end of every year, until the expiration of the said six years, and thereupon the Deputy Master guardian of the said Henry Bittle here in Court acknowledged himself to be indebted to Thomas M. Randolph Esq. Governor or Chief Magistrate of this Commonwealth in the sum of five hundred dollars of his goods and chattels, lands and tenements to be levied and to our said Governor and his successors for the use of the use of the Commonwealth rendered. Yet upon this condition that if the said Henry Bittle shall come and perform the above order of this Court against him as aforesaid, then this recognizance to be void.
