

Levy, Walter, Henry, Carter, William H. Barnes, Richard B. Day, Benjamin Whitaker, Henry T. Mayet, John Barrett, were sworn a grand jury of inquest for the body of the County and after receiving their charge were sent out of Court and after sometime returned into Court and presented the Surveyor of the said leading from Nathan Pope to Whitehead's meeting house for not keeping the same in repair according to Law by the information of Richard B. Day and William H. Barnes two of our body.

Also presented James Wells for selling by retail spirituous liquors to wit one pint of apple brandy to Joseph Buffin and one pint to Tyler Edwards on the 11th of this present month March, to be drank when sold (to wit) at his own house in this County and within the jurisdiction of this Court without having obtained a Tavern License for that purpose according to Law. By the information of Tyler Edwards one of our body sworn in Court to give evidence to his fellows.

Also presented Elizabeth Turner for feloniously stealing, taking and carrying away goods belonging to James Williams on the 19th of September 1819 to wit, two powder barrels and one sauce by the information of James Williams one of our body sworn in Court to give evidence.

Also presented Elizabeth Turner for feloniously stealing, taking and carrying away goods belonging to James Whitehead on the 18th September 1819, to wit, one powder dish and one stone pitcher by the information of James Whitehead sworn in Court as a witness to give evidence.

And also presented Elizabeth Turner for feloniously stealing, taking and carrying away one space one earthen Jar and one chamber pot the property of Joseph Butler on the day of 1819 by the information of Joseph Butler sworn in Court as a witness to give evidence to the Grand Jury. And the Grand Jury having nothing further to present were discharged.

Ordered that James Wells be summoned to the next Court to answer a presentment of the Grand Jury against him made this day, and also to show cause why an Information should not be filed against him upon the presentment aforesaid.

On the motion of William J. Moore it is ordered that Master Commissioner Cobb do examine State and settle an account of the said Morris Guardianship of the orphans of Robert Dabby deceased and make report thereof to Court.
