On the motion of James Turner who made oath and together with Henry Porter and Levi Waller his securities entered into and acknowledged a bond in the penalty of two thousand dollars conditioned as the Law directs Certificate is granted the said James Turner for obtaining letters of administration on the estate of Mildred Turner deceased in due form.

Ordered that Henry Porter, Elisha Atkinson, John Wauzhan and Peter Edwards or any three of them being first duly sworn before a Justice of the Peace for that purpose do view and appraise all the personal estate to them produced of Mildred Turner deceased and return such appraisement under their hands to Court.

On the motion of John Demegre who made oath and together with his Security entered into and acknowledged a bond in the penalty of his Security conditioned as the Law directs Certificate is granted the said John Demegre for obtaining letters of administration on the estate of Eliza Pierce deceased in due form and administered by the former administrator.
