

Ordered that Rollin Kitchin, Matthew Calvert and James Rochelle or any two of them do examine, state and settle the account of Richard H. Clements late Sheriff of Southampton with the County for the year 1819, and an additional account for the year 1828 and make report thereof to Court.

Henry Briggs and Charles Briggs are by George Haines Sheriff of this County, appointed his deputy sheriffs during pleasure, and the Court being of opinion that the said Henry and Charles Briggs are men of honesty probity and good accounts, they severally took the oath of fidelity to the Commonwealth, the oath prescribed by the act entitled "An Act to suppress swelling" the oath to support the Constitution of the United States and the oath of office.

Ordered that John Warrick Executor of James B. Warrick deceased be summoned to the next Court to show cause if any he can, why an attachment should not be sued forth against him for his contempt in failing to comply with the order of this Court directing him to render an account of his Administration on his Testator's estate.

On the motion of Lawrence Keck Guardian to Martha & William or formerly Martha & Edward It is ordered that Master Commissioner Keck do examine, state and settle an account current of his guardianship aforesaid and make report thereof to Court.

Ordered that Master Commissioner Keck do examine state and settle an account current of Peter Barretto's administration on James Barretto's estate and make report to Court.

On the motion of John Martin It is ordered that Master Commissioner Keck settle an account current of Arthur Harris administration on the estate of Solomon Gwynne's estate and make report thereof to Court.

On the petition of Branch W. Deville, Nathan Jones, John Abzughart, Royal Harris, John Mundall, William Simmons, Arthur Williamson, Samuel Calvert, Spratley Williams and Henry Gurley who produced the Sheriff's receipt for the tax imposed by laws and severally entered into bond with security in the penalty of one hundred and fifty dollars conditioned according to law. a license is granted each of them to keep an ordinary at their respective houses till 1st day of May next. The Court being satisfied that they are men of honesty and probity and not addicted to Drunkenness or gaming.

Upon the information of Nathaniel Sturges Commissioner of the Revenue for the County of Southampton and Parish of Saint Luke. It is ordered that Elizabeth Davis be summoned to the next Court to show cause why she should not be fined for refusing to give a list of persons or property subject to taxation in her possession when applied to by the said Commissioner.

Elizabeth Uzzell who was this day set to the Bar by the Sheriff of this County into whose custody she was heretofore committed and charged with having on the 29th day of April last, stolen, taken and carried away from the Stand of Nicholas F. Cook a pedlar exhibiting in the town of Jerusalem, three shells, of the value of three dollars and two cents of the value of fifty cents (the Court summoned for her examination not having met) and thereupon divers witnesses were sworn and examined on behalf of the Commonwealth, touching the premises to wit Nicholas F. Cook, James A. Gray, Matthew Calvert and Epe Drury.
