To wit, Jack, Harry, and Nancy, also to Mary Ann Myrick the balance of said Slaves to wit Tom (short), Robin, Harlin, Sanchez, Selby, Nat, Fortune, Amy, and Dary and find in making said division that Mary is indebted to said James Myrick the sum of sixty seven Dollars 59 cents Given under our hands this 11th day July 1820. Joseph Gilliam, Arthur Williamson, Joseph Harris."
