

He assigns one fourth part in right of his wife Elizabeth who was formerly Elizabeth Johnson. He also assigns to the said David Clark as Guardian for Betty & Miles Johnson each one fourth part & the remaining fourth part He assigns to Betty Johnson which gives to each legatee the sum of One hundred & fifty dollars & 25 Cents. Given under our hands this 3^d day of November 1820. Law. Clerk Anthony Woodward. J. B. Bailey. Whereupon by consent of parties It is ordered that the report aforesaid in form aforesaid made be confirmed & approved and the costs equally borne between the parties -
