Warden and Jacob Gardner his securities entered into and acknowledged a bond in
the penalty of three hundred dollars conditioned as the Law directs, certificate
is granted the said William for obtaining letters of administration on the
estate of his late wife Elizabeth Ellis dec'd in due form.

Polly Bulls and Sally Bulls orphans of William Bulls dec'd with the
approbation of the Court made choice of John Bulls for their Guardian, and
whereupon she paid John with Robert Nicholson, James C. Foster his secu-
rities entered into and acknowledged a bond in the penalty of three thousand
dollars conditioned according to Law.

A Deed of Bargain and Sale from James Dillard Executor of Richard
Dillard to Joseph H. Hollister was acknowledged in the Clerk's Office and admitted
to record since the last Court. A Certificate was also day returned to Court and
ordered to be entered among the proceedings of the day.
