John Murgahart having obtained an attachment against the estate of Mills Eley who hath privately removed out of this County or so absconds or conceals himself that the ordinary process of Law cannot be served upon him for debt for \$75.20 cents with by account. and Jesse Baley Constable having made return that he has executed the said attachment on the estate of the defendant in the hands of Josiah Holliman and summoned him as garnished. This day came as well the plaintiff by his attorney as the said garnished in his proper person who being sworn, declared that he was indebted to the defendant in the sum of three hundred and thirty nine dollars & eighty cents and no more. and the said defendant still failing to appear the solemnly called, and it appearing to the satisfaction of the Court that the defendant is indebted to the plaintiff in the sum of three hundred and seventy one dollar & fifty one cents, it is considered by the Court that the plaintiff recover against the said defendant the said sum of three hundred and seventy one dollar & fifty one cents and his costs by him in this behalf expended. And it is ordered that the said Josiah Holliman pay to the plaintiff the said sum of \$371.51 cents or so much thereof as will be sufficient to satisfy this judgment - and the balance pay towards satisfying a Judgment this day rendered in favor of Robert Murray against the said defendant Eley -

Robert Murray having obtained an attachment against the estate of Mills Eley who hath privately removed out of this County or so absconds or conceals himself that the ordinary process of Law cannot be served upon him and for \$25.50 cents due by account and Jesse Baley Constable having made return that he has executed the said attachment on the estate of the defendant in the hands of Josiah Holliman and summoned him as garnished. This day came as well the plaintiff by his attorney as the said garnished in his proper person who being sworn, declared that he was indebted to the said defendant in the sum of three hundred and thirty nine dollars eighty cents and no more. and the said defendant still failing to appear the solemnly called, and it appearing to the satisfaction of the Court that the Defendant is indebted to the plaintiff in the sum of \$25.50 cents it is considered by the Court that the plaintiff recover of the said defendant the said sum of twenty five dollars and fifty cents and his costs by him in this behalf expended. And it is ordered that the said Josiah Holliman after having satisfied the judgment this day rendered in favor of John Murgahart against the defendant and the monies due from him to the said defendant, pay the balance over to the plaintiff towards satisfying this judgment -

This day came as well the said Plaintiff by his attorney as the said garnished in their proper persons who being sworn, the said Thomas Pond deposed that he was the trustee in a Deed in trust from the defendant to Merrill M Eley which is filed in this cause, that he knows nothing of the consideration, the consideration of the said Deed or any fact concerning it except eighty dollars which he saw paid. And the said Merrill Eley deposed that he held the property mentioned in said Deed under the same, and the plaintiff claiming the said property alleging that the said Deed was fraudulent whereupon the said Merrill M Eley
