Rebecca and Ann Eliza Fitzhugh by their next friends the said Thomas Fitzhugh Esq
This cause this day came on by consent of parties for a final decree on the bill, answer and
documents filed, and the Court being of opinion that from a sound construction of the will of
John Fitzhugh his wife in the event of her marriage (which has occurred) was entitled to one
third of his estate in fee simple and not for life, and that consequently the direction to the Commis-
sioners who acted under the interlocutory decree in this cause to allot the said one third to the said
Snyder and wife for life of the said wife was in this particular erroneous - It is therefore decreed
and ordered that the report returned by the said Commissioners be confirmed except that the said
Snyder and wife hold the proportion allotted to them by the said report not for life but in fee
simple in right of the said wife and that each party pay his own costs -
