

Ordered that the Sheriff of this County make sale Jacob Riets, Jacob Bailey, Dick Blackshins, Anthony Riets, Ned Spralleg, Will. Evans, Leshannon Roberts, Mike Roberts, and Doctor Bailey, free negroes for the purpose of paying their taxes & in pursuance of an Act of Assembly in such case made and provided -

On the motion of Nathan Pope. Ordered that he be exempt from the payment of taxes & levies for his negroes Jacob & Molly in future -

Ordered that the estate of Samuel Turner be exempt from the payment of taxes and levies for his negroes Lydia & Bridget, in future -

William A Holsey this day produced the Sheriff's receipt for the tax imposed by law on hawkers and pedlars. Therefore, on his motion, It is ordered that a license be granted him to retail goods wares and merchandise, as hawker and pedlar, within this Commonwealth, till the 30th day of April 1822 -

Ordered that Alexander P Tate procure weights and measures for this County according to the Act of Assembly, and that he be appointed keeper of the same until the further order of the Court -

Be it remembered that Henry Cutler, with William Cutler and Henry T Magee his securities here in Court acknowledged ^{themselves} severally indebted to his Excellency Thomas M Randolph esq. Governor or Chief Magistrate of this Commonwealth, that is to say, the said Henry T Cutler in the sum of \$100. and the said William Cutler & Henry T Magee in the sum of \$50. each of their respective goods and chattels lands and tenements to be levied, and to the said Governor and his Successors for the use of the Commonwealth rendered - Yet upon this condition that if the said Henry Cutler shall keep the peace and be of good behaviour towards all the citizens of this Commonwealth more especially towards William Davis of the County of Sussex, for the term of six months from this day then the above recognizance to be void or else to remain in full force and virtue -

Be it remembered that William Davis with Matthew Calvert & Henry T Magee his securities here in Court acknowledged themselves severally indebted to his Excellency Thomas M Randolph esq. Governor or Chief Magistrate of this Commonwealth, that is to say the said William Davis in the sum of \$100. and the said Calvert & Magee in the sum of \$50 each of their respective goods and chattels, lands & tenements to be levied and to our said Governor and his Successors for the use of the Commonwealth rendered. Yet upon this condition that if the said William Davis shall keep the peace and be of good behaviour towards all the citizens of this Commonwealth more especially towards Henry Cutler of this County, then the above recognizance to be void or else to remain in full force & virtue -
