

in these words to wit: "In pursuance of an order of the County Court of Southampton, now, we the undersigned three of the Commissioners named in said order, in pursuance thereof, have let to the best undertaken the building of a Clerk's Office in compliance with the annexed plan and report, to be completed on or before the first day of June 1823 and that Clements Rochelle became the undertaker at the price of fourteen hundred and eighty five dollars who gave bond with James Rochelle his security which is hereto annexed. And we also report that it is the opinion of the acting Commissioners that it would be advisable to change the site of the said Office so as to have the old store house on the public ground taken away and the Office set on a situation so that it may be connected with a new Courthouse when the Court should think proper to build one, or at least place it in a situation more contiguous to the present Courthouse, all which is respectfully submitted. 7th September 1822. Whereupon it is ordered that the site of the said Office be changed as proposed by the said Commissioners -

Ordered that Benjamin Cobb, Cam Borrers, Henry Briggs, James Rochelle, and Jeremiah Cobb be a committee appointed to let such repairs to the Jail of the County as they or a majority of them shall think proper and necessary, and the said Committee are also directed to devise a plan for the building of a new Jail for this County and make report thereof to Court -
