This cause came on this day by consent of parties upon the report of
Master Commissioner Cobb and upon exhibit marked, A, as a supplement thereto
whereupon the Court doth adjudge, order and decree that the said report with
the supplement be in all things affirmed and that the defendant James
Dillard as administrator of the said Richmond Dillard pay to the complain-
ants as follows, that is to say to Edwin H Hart in right of his wife the sum
of six hundred and ten dollars thirty eight cents with interest thereon from
February the 22nd 1822 till paid and that the said Edwin H Hart recover of
the said James Dillard administrator as aforesaid the sum of forty two
dollars and forty cents due January the 1st 1823, and the further sum of forty
two dollars and forty cents due January the 1st 1824. That the said James
Dillard Administrator as aforesaid pay to Edwin H Hart guardian to Augustus
Hart his son the sum of eighty four dollars and eighty four cents with
interest thereon from February the 22nd 1822 till paid, and that the said
Edwin H Hart guardian as aforesaid recover of the said James Dillard
Administrator as aforesaid the following sums to wit, the sum of twenty one
dollars and twenty cents due January the 1st 1823 and the further sum of
twenty one dollars and twenty cents due January the 1st 1824, that the said
James Dillard Administrator as aforesaid pay to Edwin Harris in
right of his wife Mary the sum of seven hundred and forty dollars and
thirty one cents with interest thereon from the 22nd February 1822 till paid
and that the said Edwin Harris recover of the said James Dillard Admin-
istrator as aforesaid the following sums to wit, the sum of two hundred
and thirty three dollars and twenty three cents due January 1st 1823 and
the further sum of two hundred and thirty three dollars twenty three cents due
