James M Beale orphan of Elizabeth Beale deceased made choice of Charles W Goodwyn for his guardian and thereupon the said Charles W Goodwyn with John T Laughan and Bolling M Barnes his securities entered into and acknowledged a bond in the penalty of six thousand dollars conditioned as the law directs.

The Court doth assign Richard Porter guardian to Thomas Porter and Septhah Porter orphans of Thomas Porter deceased and thereupon the said Richard Porter together with Bolling M Barnes and Jacob Williams his securities entered into and acknowledged a bond in the penalty of five thousand dollars conditioned according to Law.

On the motion of Edmund Turner who made oath and together with Richard Blunt and William M Goodwyn his securities entered into and acknowledged a bond in the penalty of two hundred dollars conditioned according to Law certificate is granted him for obtaining letters of administration on the estate of Henry Banty deceased in due form.
