 that they be sold on a credit of twelve months and the proceeds of the sale divided
 into four equal parts, each part thereof is to be secured by bond with good security
 and one bond delivered to each of the complainants. And that *Scarrence Cook*
Richard Hunt, *Giles Barnett* and *Bruton Bryant* or any three of them do carry
 the latter part of this decree into effect and make a report thereof to this Court in
 order to a final decree.

On the motion of the plaintiffs by their Attorney *James Rochelle* is ap-
 peared Guardian to the defendant to defend her in this behalf and thereupon this cause
 was this day docketed by consent of parties and of part of the Court and was heard
 on the bill and answer and argument of Counsel. Whereupon the Court doth
 adjudge, order and decree that the tract of land lying in this County and to
 contain thirty nine acres which descended to the plaintiffs and defendant in
 this cause by the death of their mother *Martha Capell* be sold on a credit till
 the 25th day of December next. That the proceeds of the sale be divided into five
 equal parts the payment whereof is to be secured by bond with good personal
 security and delivered over one to the Guardian of each of the plaintiffs and
 one to the Guardian of the defendant and that a conveyance in fee simple
 be made to the purchaser of said land. And it is moreover ordered that *Humph-*
rey Drowry, *Must Harris*, and *William B. Goddard* or any two of them do
 carry the foregoing part of this decree into execution and make report to
 this Court of their proceedings in order to a final decree.

Ordered that *Richard Murfee* be summoned to April Court next to
 show cause why he should not be ruled to give counter security for his acting
 and doing as Guardian to *Henry* and *Nancy Foster* orphans of *William*
Foster deceased.
