This day came the parties by counsel and the persons appointed by an order of the County Court made in this cause at January Court last for the purposes therein mentioned this day made the following report. "Accordingly to an order of the County Court of Southampton to us directed dated January Court 1823 we the commissioners as expressed in the order aforesaid have gone on the land of Lion Hill dec^d attended with the County Surveyor as by the order we were required and run out the same and find there to be in the whole tract Three hundred and twenty eight acres. And we have divided the same in manner & form following to wit. A house lot containing Ninety acres allotted to Patsy Hill widow of said Lion Hill dec^d being her full proportionable part of the land of said decedent as her dower and bounded as follows to wit Beginning in the run of the Swamp a new corner made between S^r Patsy Hill widow and Polly Hill infant. thence along a new line of marked trees S 78° W 156 poles to a white oak stump standing near Cross road in John D Hart's line a new corner made between Patsy Hill widow and Polly Hill infant thence along said John D Hart's line S 70 1/2° E 51 poles thence S 62° E 8 poles to a grass pine thence S 19° E 11 poles thence S 22° E 10 poles thence S 26 1/4° E 10 poles thence S 28 1/2° E 13 poles thence S 30° E 33 poles to a small persimmon tree a new corner made between said Patsy Hill widow and Green Hill in said John D Hart's line, thence along a new line of marked trees S 68 1/2° E 102 poles to the run of Bull Hill Swamp a new corner made between said Patsy Hill widow and Green Hill thence up the said Swamp to the beginning including all the boundaries of the house lot which was allotted to the aforesaid widow as her dower.
