Ordered that Robert Fretton, Joseph Fretton and Edwin Williford or any two of them with persons appointed by the County Court of Isle of Wight let to the lowest undertaker the repairs of Fretton's bridge and make report thereof to Court

It appearing to the satisfaction of the Court that Nathan Harris is a man of insane mind, and the Justices who held an examination for the purpose of ascertaining that fact this day made their report which is ordered to be recorded. Therefore on the motion of Newt Harris ~~he was appointed~~ committee of the person and estate of the said Nathan Harris on his giving bond and security in the penalty of ten thousand dollars conditioned as the Law directs, which is accordingly done -

On the motion of Richard Darden Executor of John Carr dec^d and Nathaniel Pope Jr. setting forth that they are bound in this Court as securities of Matthew Underwood surviving administrator of Mary Underwood dec^d and that they conceive themselves to be in danger of suffering damages by reason thereof and praying the Court for relief.
