On the motion of Redmond Holt who filed his bill an injunction is granted him to inform the Plaintiff her agents attorneys and all others concerned from all further proceedings on a judgment obtained against the said Redmond Holt in this Court by Elizabeth Turner, as to the sum of ten dollars and seventy five cents with legal interest thereon from the 1<sup>st</sup> day of July 1821, on his giving bond and security in the clerk's office according to law within two months from this day.
