This day came as well the Attorney for the Commonwealth as the defendant by his Attorney and the defendant, said he is not guilty in manner and form as in the information against him is alleged and of this he put himself upon the country and the attorney for the Commonwealth likewise, and thereupon came a jury to wit Benjamin Hines, William Carter, Charles Smith, Robert Bordenyer, Belah St. Fitch, Richard B. Day, William Dowers, Matthias Williams, William O'Leary, Joel Williams, Lewis Morrell, who being elected tried and sworn and Thomas Johnson who being elected tried and charged the truth to speak upon the issue joined upon their oath returned a verdict in the following words to wit: "We the jury find the defendant guilty and assess the fifteen dollars." Therefore it is considered by the Court that the Commonwealth recover against the defendant the fine aforesaid by the jury aforesaid in their verdict assessed, and that the defendant also pay the costs of this prosecution. And the said defendant may be taken &c.
