This cause was this day docketed by consent of parties with the assent of the Court and was heard on the bill, answers, exhibits filed and argument of counsel. Whereupon the Court doth adjudge, order and decree that the land lying on Tuckwatumbo Swamp of which the said Henry Blon died seized, a water-grist mill thereto attached and such personal property as was found by the said Henry Blon to the defendant Mary D. Blon and which she may choose to surrender for that purpose be sold on a credit of one, two and three years reasonable public notice of the time and place being first given, and that the proceeds of the sale be divided into five equal parts and secured by bond with approved security, and that one bond be assigned over to the Complainant Robert Goodwyne in right of his wife Margaret B. and one to the guardian of each of the defendants, James Henry, Robert & Samuel Blon. And it is moreover ordered that Benjamin Blunt jr. do carry the foregoing decree into effect and make a conveyance in fee simple with special warranty to the purchaser of said land and make a report to this Court in order to a final decree. And six months are allowed the infant defendants after they arrive to lawful age to contest this decree.

On the motion of James Tregant guardian to Samuel Blon orphan of Henry Blon dec'd he is permitted to withdraw himself as guardian as aforesaid. And thereupon the Court doth assign Robert Goodwyne
