The Court doth assign Lawrence Cook Guardian to Richard Gray orphan of Benjamin Gray dec^d. and thereupon the said Lawrence Cook together with Bailey Bryant and Nathaniel Rochelle his securities entered into and acknowledged a bond in the penalty of one thousand dollars conditioned according to Law.
