Therefore it is ordered that the said Manuel Hurst be charged with the annual payment of ten dollars to the Overseers of the poor of this County for the space of two years from this day in case the said child should live & bring, and that the said Manuel Hurst pay the same to them accordingly at the end of every year until the expiration of the said term of two years. And thereupon the said Manuel Hurst together with Lewis McCord his security here in Court acknowledged themselves to be jointly and severally indebted unto James Pleasant, Clerk of this Commonwealth in the sum of fifty dollars each, of their respective goods and chattels, lands and Tenements to be levied and to the said Governor and his Successors for the use of the Commonwealth rendered. Yet upon this condition that if the said Manuel Hurst shall observe and perform the above order of the Court made against him as aforesaid then this recognizance to be void.
