into five equal parts, having regard to value, and one fifth part be allotted to the defendant Elijah
Scarbrough, one fifth part to Britton Scarbrough, one fifth to Joel Holt and his wife Fanny, in right
of his wife, one fifth to Benjamin Grimes, and Priscilla his wife in right of his wife, and one fifth
to Mary Ramsey. And it is further ordered that Willie Frances, David Newsum, Benjamin
Turner and James Jackson do carry the foregoing decree into effect and make report to this
Court in order to a final decree.

Josiah Jones who was bound by recognizance for his appearance here this day to answer the
Complaint of John Travis against him for a breach of the Peace this day appeared in discharge of
his recognizance, and thereupon the said John Travis being sworn and examined and the said
Josiah Jones fully heard it is the opinion of the Court, and accordingly, ordered that the said
Josiah Jones give security for his keeping the peace for the term of twelve months from this day
himself to be bound in the sum of One hundred dollars with two securities in the sum of fifty
dollars each. Whereupon the said Josiah Jones together with Mary Kitchin and Sarah Kitchin
his securities here in Court severally acknowledge themselves to be indebted to his Excellency James
Pleasants Esquire Governor of the Commonwealth of Virginia and his Successors, the said
Josiah Jones in the sum of One hundred dollars and two securities in the sum of fifty dollars
each of their respective goods and chattels, lands and Tenements to be levied and to the said
Governor and his Successors for the use of the Commonwealth rendered. Yet upon this condition
that if the said Josiah Jones shall keep the peace and be of good behaviour towards all the Citizens
of this Commonwealth more especially towards John Travis for the term of twelve months from
this day then the above recognizance to be void or else to remain in full force and virtue.
