For a negro man slave the property of Edward Butts of this county was this day set to the bar by the Sheriff of this county into whose custody he was hitherto committed and charged with breaking & entering the dwelling home of said Edward Butts of this county & thereout stealing taking & carrying away a ponce of brandy (the court summoned for his trial not having met) and the prisoner being fully heard by counsel - The court after hearing the testimony and all the circumstances of the case are of opinion that the prisoner is guilty. Therefore it is ordered that he receive 39 lashes on his bare back and that the Sheriff see execution thereof done & the same being done & performed & proclamation being made in the manner is and nothing further being alleged ag^t him it is ordered that he be discharged from further prosecution in this behalf.
