At a court summoned and held for the county of Southampton on the 15th day of June 1826 for
the examination of Henry Hunt, who stands charged with feloniously committing a rape
on the body of Loney Jordan of this county near the home of Washington Hurst of this county on the night
of the 9th of April 1826 -

Pres^t. Clements Pochelle, Benjⁿ Devany, Thomas Patton, Robert ~~Edwards~~ & M^r. C. Daughton

The court being thus constituted the prisoner was set to the bar by the Sheriff of this county into whose
custody he was heretofore committed and charged with the felony aforesaid and thereupon divers witnesses were
sworn and examined on behalf of the commd. Touching the premises to wit Loney Jordan, Richard Jordan,
and Nicholas Nick. The court after hearing the testimony and all the circumstances of the case are of
opinion that the said Henry Hunt ought to be tried for said offence at the next Superior court
to be holden for this county and thereupon it is ordered that he be removed to jail

Be it remembered that Loney Jordan, Rich^d. Jordan & Nicholas Nick here in court acknowledged
themselves indebted unto his Excellency John Tyler Esq. Governor or chief magistrate of this commd and
his Successors in office for the time being in the sum of \$333 33/3 cents each to be levied of their
respective goods & chattels lands & Tenements and to the said Governor for the use of the bond and
yet upon this condition that if they and each of them shall personally appear before the Judge
of the next Superior court to be holden for this county on the first day of the next Term of said
court by 10 o'clock of that day then & there to give such evidence as they & each of them know in
behalf of the bond against Henry Hunt who stands charged with committing a rape on the
body of Loney Jordan & shall not depart thence without leave of the court then this recognizance
