At a Court of Quarter Sessions continued and held for the County of Southampton at the Court house on Tuesday November 17th 1829 -

Ordered that the acct. of Horrell Harris Linch amounting to \$273 cents be certified to the Auditor of Public accounts for his examination & payment -

Ordered that Alex. Myrick & Augustin Pope (being sworn &c.) state settle and adjust an account of Seps Wills comin on John West dec'd est: & make report & Cherry in Darden. leave. The defendant by his Atto. filed his pleas & thereupon the judgment obtained against him in the Office is set aside
