Governor of the Commonwealth of Virginia the said Fells in the sum of \$50 and the said Rice & Harrison in the sum of \$25 each of their respective goods & chattels, lands & tenements to be bound and to the said Governor and his successors for the use of the Commonwealth rendered. Not upon this condition that if the said Lewis Fells shall keep the peace towards the Commonwealth and all its citizens for 12 months from this day then this recognizance to be void or else to remain in full force.
