 On the motion of Clements Rachelle Chff of this County Stephen Moreaugh
 qualified as his deputy during his pleasure. The Court being of opinion that
 the said Stephen Moreaugh is a man of honesty probity & good demeanor
 Rachelle Scott and Polly Scott free persons of color who stand as committed to the
 Jail of this County for feloniously breaking, entering in and carrying away from
 the cellar of the dwelling of James D. Mapenburg on the 31st of February 1830
 sundry articles of property of the value of \$10. was set to the bar in custody of the
 Jailor of this County (The Court summoned for their examination not having met.)
 and thereupon James D. Mapenburg a witness for the Commonwealth being sworn &
 examined & the Alts. for the Com. & the prisoners by their Counsel being fully
 heard, it is the opinion of the Court that the prisoners ought to be tried for the
 said offense at the next Sup. Court of Law to be held for this County & thereupon
 they are remanded to Jail.
