

It is by the Court ordered that Messrs. Bowers, Robert Murray, Jacob J. Williams and James Holmes or any three of them who are hereby appointed Commissioners for the purpose do proceed to confer with such Commissioners as have been appointed by the County Court of Isle of Night County in respect to the point on the Black Water River beyond the Portsmouth of Roanoke rail road, to which McBlenny's Bridge may be most properly removed, and that they further proceed in connection with the said Commissioners of Isle of Night to contract with such person or persons as will undertake the removal and erection of the said Bridge at the least expense to the County; the undertaker or undertakers entering into bond payable to the Governor of the Commonwealth as the Law in such case prescribe and that they further proceed to ascertain and designate the course which the road leading from the point, to which the said bridge shall be removed, to some point on the old road or such other place as they shall think best, letting out the same in like manner to such person or persons as will undertake the construction thereof.

Pursuant to the Act of Assembly the Court doth order and direct that for the purpose of partitioning the lands in the County, the same be divided into 39 precincts as follows, to wit:

- Precinct No 1. From Nottoway River up the Great Swamp to Crafford's road, down the said road to Nottoway River and down the said River to the beginning.
- No 2. From the North side of the Flat Swamp from the old parish line thence to the Cabin branch and up that to the flat Swamp and down the said flat swamp.
- No 3. Bounded by the Nottoway River and the Flat Swamp and from the old parish line to the flat Swamp, and so up to Thomas Cocks.
- No 4. Between the Indian line, Nottoway River, the Three Cocks and the creek road.
- No 5. From the Angelica Swamp bridge up the swamp to Townsend's Branch up the said Branch to the Angelica branch, then down Burrows Road to the head of Richborn down the new Road and to the said Road to the beginning.
- No 6. From the mouth of Ridgely branch to the head of George's Branch down that to Moore's meadow up that to Robin branch, up to the head of the Angelica Swamp and down the said Swamp to the beginning.
- No 7. From Robin's Branch up the south side of the Three Cocks to the County line to Richborn River down the said River to Thomas Cocks land and thence to Robin's branch.
- No 8. From the former Parish line down the Flat Swamp to Crafford's road and along the said road to the County line and up the said line to the Greenville line up that to the old parish line and along the said line to the beginning.
- No 9. From Crafford's road down the Flat Swamp to the County line, to Crafford's road, along the said road to the beginning.
- No 10. From the mouth of Blants Swamp to the mouth of Ross Swamp up that to the Indian line down the said line to Crafford's road up the said road to Flat Swamp and up the same to the beginning.
- No 11. From the parish line at the Flat Swamp down the said Swamp to the mouth of Blants Swamp up the Swamp to the mouth of Ross Swamp, up that to the Indian line along the said Branch to Townsend's branch down that to the Angelica Swamp and up that to the head of the Cabin Branch down said Branch to the old parish line thence to the beginning.
- No 12. From the old County line on the south side of the Cypress Swamp and up the same to Boon's Road, up the said line to the County line down the same to the beginning.
- No 13. From the County line at Boon's Road up the said line to the mouth of
