Butts and Rebecca his wife the descendants of James Butts, another son, of the said William Butts the brother. William Jones only descendant of Nancy Butts a daughter of William Butts another son of William Butts the daughter, the brother of the deceased. And the residue of the remaining 1/6 part or share is then to be divided between the complainants Daniel R. Butts, John T. Blou & Sally his wife George Nicholson, Albert Nicholson Lucy Ann Nicholson and George Murry they being the descendants of Robert Butts, and Polly Nicholson the only children of one Benjamin Butts, who was own brother to the said Elizabeth Mortis. In making this division, the said Daniel R. Butts is entitled to one half, representing his father Robert Butts, and the other moiety is to go to the said John T. Blou & wife Sally George Nicholson, Albert Nicholson, Lucy Ann Nicholson and George Murry who are the children and the descendants of the children of the said Polly Nicholson. The Bonds for the part or shares due to the infants are to be taken payable to the legal and proper guardian. The other bonds to be taken and made payable to the parties respectively entitled to whom the Commissioner will deliver the same, and make report of his proceedings to this Court in order to a final decree.

Joseph Ferguson is appointed surveyor of the Road in the room of John Hargrave who is excused and it is ordered that the usual hands work thereon.

Richard Edwards who is committed to the custody of the Sheriff for want of security for being of good behaviour towards all the citizens of the Commonwealth, here in Court. And upon this condition that if the said Edwards shall keep the peace and be of good behaviour towards all the citizens of the Commonwealth for the space of twelve months from this day then the above recognizance to be void.
