

Daniel M. Simmons is appointed surveyor of the road from the Barn Tavern to the fork of the Road near the old mill bridge in the room of William Hitchens deceased.

An Indenture of bargain & sale from Robert Drury to William M. Adams was acknowledged by said Drury and ordered to be recorded.

On motion of William Barden, who made oath and together with Josiah C. Ferguson, Reddick Darden, and Benjamin Beal, his securities, entered into and acknowledged a bond in the penalty of one thousand dollars conditioned as the law directs certificate is granted him for obtaining letters of administration on the estate of Mary Barden decd. in due form.

John B. Mason is assigned guardian to Rebecca & Thomas Applewhite, and thereupon he together with William B. Hodgson and Nathaniel J. Williams his securities entered into and acknowledged a bond in the penalty of thirty thousand dollars, conditioned as the Law directs.

In reasons appearing to the Court Lewis Norrell is hereby authorized to advance to the infant children of Hinchey Incey, of whom he is guardian, the sum of Twenty five dollars each to remove them to the State of Ohio.

And on the motion of Nicholas M. Debell the only executor therein named who made oath and together with William J. Debell and Zebulon S. Simmons, his securities, entered into and acknowledged a bond in the penalty of two thousand dollars conditioned as the Law directs certificate is granted him for obtaining a probate of the said Will in due form.

Ordered that James Bell, John Drake, William D. Wood and Gilbert Nick or any three of them, being first sworn before a Justice of the Peace for that purpose, do appraise all the personal estate of Nancy A. Simmons decd. and return the appraisement under their hands, to this Court.

Gilbert M. Nick is assigned guardian of Nancy B. Pond orphan of Peter Pond decd. and thereupon he together with John Nick and James Nick, his securities, entered into and acknowledged a bond in the penalty of Five Thousand dollars conditioned as the Law directs.

On motion of John Cozum who made oath, and together with Samuel M. Pond and Robert Drury his securities, entered into and acknowledged a bond in the penalty of one hundred dollars, conditioned as the Law directs certificate is granted him for obtaining letters of administration on the estate of Robert Cozum decd. in due form.

Ordered that Master Commissioner Cobb examine, state and settle John Cozum's administration on the estate of Robert Cozum decd. and make report thereof to this Court with any matters specially stated assumed pertinent by himself or which he may be required to state.

Benjamin Beal is assigned guardian to Joshua Ferguson orphan of William Ferguson decd. and thereupon the said Benjamin Beal together with Abner Riddick, John C. Turner and James Rager
