Samuel H. Holmes is assigned guardian of Martha Bailey orphan of Jesse Bailey decd. and thereupon he, together with John Brown his security, entered into and acknowledged a bond in the penalty of Fifty dollars conditioned as the Law directs.

In motion of Bennett R. Whitfield who made oath and together with William M. Cutler and Benjamin Whitfield his securities entered into and acknowledged a bond in the penalty of Two hundred dollars conditioned as the Law directs, Certificate is granted him for obtaining letters of administration on the estate of Sally Powell decd. in due form.

Darden M. Bryant is assigned guardian to Nathan J. Williams orphan of Miles Williams decd and thereupon the said Darden M. Bryant together with Abner R. Stephenson and Herbert M. Bryant his securities entered into and acknowledged a bond in the penalty of Four thousand conditioned as the Law directs.

In the motion of John R. Williams for leave to open a new Road, - The Commissioners of Roads to whom the application was recommended this day made an additional Report which is ordered to be recorded and is as follows. Agreeably to an order of the Honorable Court of Southampton County dated September Court 1818 and hereunto annexed, the undersigned Road Commissioners, in obedience to the requisitions of said order, have reviewed the Route for a Road from Hapenbury's Mill to Crockettville, and are still of opinion that a Road located there would be useful, and in addition to the reasons stated in our former Report, should the navigation of the Nottoway River be improved it would be more so. By changing the former Road on the
