Ordered that Master Commissioner Webb examine state and settle an account of Benjamin Derang's administration on the estate of Joseph R. Reed and make report thereof to this Court with any matters specially stated deemed pertinent by himself or which he may be required to state.

A Deed of bargain & sale from Edwin Gardner and Elizabeth C. his Wife, was acknowledged by said Edwin Gardner to be his act and deed and with the certificate annexed of the proper examination and acknowledgment of his Wife, ordered to be recorded.

Ordered that the estate of Polly Clements and be committed to the hands of Benjamin Griffin Sheriff of this County for administration according to Law.

The Commissioners heretofore appointed to view and report to the Court whether in their opinion the bysses bridge may not with convenience to the public as well as to individuals, be removed to some other site - this day made their report which is ordered to be recorded and is as follows: "In obedience to the within order we Henry Blow, John M. Thomas & Samuel P. Nicholson have examined the bysses bridge and think it necessary there should be a new Bridge entirely and so bridge should be built upon piles. Henry Blow John M. Thomas Samuel P. Nicholson. 12th Jan 1838" And it is ordered that the said Commissioners to wit Henry Blow John M. Thomas Samuel P. Nicholson & Shadrach Turner or any three of them let to the lowest undertaker the rebuilding of the said Bridge on piles as indicated in the report of the Commissioners in their report, the said New Bridge to be built at the direction of the Commissioners running parallel with and near the present bridge, that they receive the said Bridge when complete and make report thereof to the Court.

Ordered that Jordan Edwards be exempted from the payment of taxes and fines for his slave Rose in future she being future - he being aged and infirm.

Ordered that Master Commissioner Webb examine state and settle an account of Robert I. Musgrave & Peter Edwards's Executors proceedings on the estate of Newell Morris and make report thereof to this Court with any matters specially stated deemed pertinent by himself or which he may be required to state.

Ordered that Master Commissioner Webb examine state and settle an account of Peter Edwards's Guardianship of Virginia Edwards and make report thereof with any matters specially stated deemed pertinent by himself or which he may be required to state.

Ordered that Master Commissioner Webb examine state and settle an account of Peter Edwards's administration on the estate of James Turner and make report thereof to this Court with any matters specially stated deemed pertinent by himself or which he may be required to state.

An Inventory and appraisement of the estate of John Cooper decd. was returned and ordered to be recorded.

Ordered that Master Commissioner Webb examine state and settle an account of John A. Person's administration on the estate of David Newsome decd. and make report thereof to this Court with any matters specially stated deemed pertinent by himself or which he may be required to state.

By consent of parties the indentures by which Thomas & Julia free negroes were bound to John A. State to and
