By consent of parties the Interlocutory Decree pronounced in this cause at December Court 1836 is so amended as to substitute Edwin B. Cloud as a Commissioner in the room of Robert T. Maguire heretofore appointed and it is further ordered that the Commissioners make report to this Court.

Ordered that Master Commissioners Robt examine state and settle an account of Richard Peters Guardianship of Robert Peters decd and make report thereof to this Court with any matters specially stated deemed pertinent by himself or which he may be required to state.

Ordered that Jacob Barnes, Thomas B Morrell and John C Turner or any two of them be appointed Commissioners, being sworn for that purpose, to state settle and adjust an account of Jacob Jordan's administration on the estate of Margaret Wick decd and make report thereof to this Court.

An Inventory and appraisement of the estate of Robert Jones decd was returned and ordered to be recorded.

An Inventory and appraisement of the estate of William Lawrence decd was returned and ordered to be recorded.

An authenticated copy of the last Will and Testament of Edmund Turner decd was returned and ordered to be recorded and on the motion of John C Turner the executor therein named, who made oath and together with Howell Harris, Nathl Jones and Nathan N Thomas, his securities, entered into and acknowledged a bond in the penalty of one thousand dollars conditioned as the Law directs heretofore is granted him for obtaining a probate of the said Will in due form.

A Deed of Trust from Benjamin Burdett to Jonathan T. Griffin trustee for Jacob Barnes was acknowledged by all the parties thereto to be their act and deed and ordered to be recorded.

A Certificate of the qualification of Samuel Kello as Commissioner of the Revenue was returned and ordered to be recorded and is as follows. "I Samuel Kello do swear that as Commissioner of the revenue for Southampton County I will to the best of my skill and judgment diligently and faithfully execute the duties of the said office, without favour affection or partiality, and that I will do equal right and justice according to the best of my knowledge in every case in which I shall act as Commissioner. So help me God. - Southampton County to wit I certify that Samuel Kello took the above oath before me as magistrate for said County this day given under my hand this 12th day of January, 1838. Edward B. Bull's J.P."

Ordered that Master Commissioners Robt examine state and settle an account of Robert T. Maguire's administration on the estate of James Ayrick decd and make report thereof to this Court with any matters specially stated deemed pertinent by himself or which he may be required to state.

On the petition of George A. M. Newson, setting forth that he is bound in this Court as security for Ann Nicholson as guardian for the orphans of Seth Nicholson, and that he conceives himself in danger of suffering by occasion thereof, and (praying) the Court for relief: It is ordered that the said Ann Nicholson be summoned to the next Court to show cause why she should not be ruled to give the said Newson good counter security.
