This cause came on again this day to be heard by consent of the parties, on the papers formerly read and upon the recommended report - under the order of November Court 1835 to which no exceptions were filed and was argued by Counsel - And it appearing to the satisfaction of the Court, by the said report, together with receipts and refunding bonds of the Complainants here to the Court produced that they have received from the defendant the several portions to which they were respectively entitled, and the Defendant admitting that he hath received from Genl. William Lambert agent for the Complainants, the sum of Two hundred and sixty one dollars and forty one cents the sum mentioned in the report with which the said Lambert was chargeable, the Court doth adjudge, order and decree that the said report be confirmed, and that the same be made firm and stable between the parties - and that the costs of this suit be borne and paid equally between the Complainants -
