This day came the parties by their Counsel and the Commissioners appointed to act under the interlocutory decree pronounced in this cause at December Court last made the following report "Agreeable to the annexed decree the Commissioners therein named did on the 23^d day of December last expose to public sale on the premises the lands mentioned in said decree and Clements Rochelle became the purchaser who has taken possession of the tract containing eighty five acres and refuses to execute his bonds for the purchase of the tract containing One hundred and eighty acres, which he has had surveyed, and from his survey contains only One hundred and thirty acres, the Commissioners would respectfully state to the Court that when the lands was exposed for sale they were sold by the tract and proclamation made that they were held for the quantity sold, that if they contained more or less the purchaser must take them for the sum bid.
