

Ordered that Master Commissioner Webb with examine State and settle an additional account of Nathaniel Sumner's administration in the estate of Robert Michelson deceased and report the same to the Court with any matters specially stated deemed pertinent by himself or which he may be required to state.

The Court are unanimous in recommending James D. Massingbury, Thomas Preston and William L. Crockett to the Executive of this Commonwealth as fit and proper persons to execute the office of Sheriff of this County the ensuing year.

It is therefore ordered that the Indentures binding the said apprentices to the said Webb be rescinded and that the Overseers of the Poor bind the said boys to Francis S. Butts upon the said Butts paying the expenses of taking up and confining said boys.

The last Will and Testament of a Adolphus Whithead deceased was proved by the calls of Benjamin Rochelle, Samuel Dickerson and Patrick Griffin the subscribing witnesses thereto and ordered to be recorded. And in the motion of Clements Rochelle the Executor therein named who made oath and together with James Dea got his security entered into and acknowledged a bond in the penalty of Two thousand dollars conditioned as the law directs. Certificate is granted him for obtaining a probate of the said will in due form.
