On the motion of Joshua Harned setting forth that he is bound in this Court as security of
Nathan Turner as guardian of the persons of Jason Bone dec^d and that he conceives himself
to be in danger of suffering damages by occasion thereof and praying the Court for relief the
said Nathan Turner being here present in Court by consent it is ordered that the said Turn-
er give the said Joshua Harned good counter security the bond for which purpose is to be
the penalty of five hundred dollars and conditioned as the law directs. Whereupon the said
Turner with Jeremiah Snyder his security entered into and acknowledged a bond
according to the above order conditioned according to Law.

The Court doth assign Samuel Corbitt Jr guardian to Joshua Corbitt orphan of Richard
Corbitt dec^d and thereupon the said Samuel Corbitt Jr with Thomas S White and Nelson
V Corbitt his securities entered into and acknowledged a bond in the penalty of two hun-
dred dollars conditioned according to Law.

The Court doth assign William V Corbitt guardian to William H Corbitt orphan of his
father Corbitt dec^d and thereupon the said William V Corbitt with Thomas S White and Samuel
Corbitt Jr his securities entered into and acknowledged a bond in the penalty of one hundred
dollars conditioned according to Law.

The Court doth assign Willis Bull guardian to Cordius and Jacob Broadshaw orphans
of Jacob Broadshaw dec^d and thereupon the said Willis Bull with Henry Bond and
Matthew Wellons his securities entered into and acknowledged a bond in the penalty of
five hundred dollars conditioned according to Law.

The Last Will and Testament of Tabitha Lawrence dec^d was proved by the oaths of
James W Murfee Simon Murfee and Samuel R Gardner the subscribing witnesses
thereto and ordered to be recorded and on the motion of Oran Vaughan the executor
therein named who made oath and together with Harrison Webb and Allen Carter
his securities entered into and acknowledged a bond in the penalty of three hundred
dollars conditioned as the law directs Certificate is granted him for obtaining a probate
of the said Will in due form.

Ordered that James W Murfee, Samuel R Gardner, Isaac C Smith and Thomas
Harrison or any three of them being first duly sworn before a Justice of the Peace for said
purpose do appraise all the personal estate of Tabitha Lawrence dec^d and return
the appraisement under their hands to Court.

Cordius Correll and Walter Correll orphans of John Correll dec^d with the approval
of the Court made choice of Rhoda Correll for their guardian who together with James
C Little and John C Little his securities entered into and acknowledged a bond.
