

along the said branch to Cornmeal Branch, down that to the Angelie swamp and up that to the head of the Cabin branch, down said branch to the old parish line, thence to the beginning -

No. 13. From the old County line on the south side of the Bayouf swamp and up the same to the said line, and lay the said road to the County line, down the said line to the County line thence to the beginning.

No. 14. From the County line at Rons roads up the said line to the mouth of flat swamp, up that to joyful Branch, thence along Taylors road to Whiteheads path, thence down the said path to the Bayouf swamp, down the said swamp to Rons road, up the said road to the beginning -

No. 15. From Seven O'Clock along Taylors road to Tuckahatchie swamp, up the swamp to Bayouf roads road, up said road to the flat swamp, and down the said swamp to the beginning -

No. 16. From the mouth of the great branch, up the said branch to the head, thence along the line of the Rev. Mr. Burley to the head of Dicks swamp, then down the said swamp to the river, up the said river to the mouth of Tuckahatchie swamp, up the said swamp to the beginning.

No. 17. From the mouth of Reddys branch to the head of Georgie branch, down said branch to Ross meadow, up that to Robins branch, down said branch to the three creeks, down the three creeks to the mouth of the Angelie swamp, up the same to the beginning -

No. 18. From the mouth of the three creeks, up the same to the mouth of the Hornet swamp up the same to the County line, down that to Notomay River and down the said river to the beginning -

No. 19. From the mouth of the Hornet swamp up the same to the County line, up the said line to the poplar swamp, down the said swamp to the three creeks and down the creeks to the beginning -

No. 20. From the mouth of the poplar swamp up the same to the County line, up the said line to the three creeks and down the three creeks to the beginning -

No. 21. From the buckhorn bridge up the swamp to the old Indian line long said line to Rockhouse road, up the said road to the beginning -

No. 22. From Mundalls on the great road at the flat swamp, down the said swamp to the mouth of Ross swamp, up the said swamp to the road, up said road to the beginning -

No. 23. From the Notomay river Northcarolina line to the old Nansund line -

No. 24. Bounded by the old Nansund line between Blackwater and Notomay river -

No. 25. From the lands lying on the East side of St. Barnes road bordering on the old Nansund line, thence up the Black water to David Johnsons, thence up the Pearson side to the aforesaid road -

No. 26. From all the lands of David Johnson on Blackwater river up the Bayouf swamp to the road and down the road to the Pearson line -

No. 27. From all the lands on the west side of St. Barnes road and up Notomay swamp to the old parish line, along the said line to the Bayouf swamp and down the same to the said line -

No. 28. Between Notomay swamp Notomay river and the old parish line -

No. 29. All the lands between Blackwater Black Creek and the Bayouf swamp -

No. 30. All the lands from the former parish line between Blackwater and Leavenly to Franks branch, down Black creek to Blackwater -

No. 31. From the old parish line to Broad Water road and down the said road to Rons Mill swamp, down the same to the beginning -
