On consideration whereof the Court doth order adjournage and decree that William Pickens, Nathaniel Francis and Charles Peters be appointed Commissioners one two of whom may act, that they after advertising the time and place of sale for twenty days, sell to the highest bidder the eleven more slaves which were allotted to the late M^{rs} Elizabeth Harris as dower in her Deceased husband's estate. That they receive on the day of sale money enough to pay the costs of this decree. for the balance of the purchase money they are to allow a credit of six months, for which they are to take of the purchaser or purchasers bonds with good security as follows. One bond for one fifth part of the whole and assign the same to Peter Edwards in right of his wife, one bond for one fifth and assign the same to the administrator of Robert T. Musgrave in right of M^{rs} Deborah, one fifth to the administrator of Richard Warren, one to John D. Mayler in right of his wife. The remaining one fifth they shall apportion between the parties as follows, a whole share in said fifth to Peter Edwards in right of his wife, the administrator of Robert T. Musgrave, the administrator of Richard Warren, John D. Mayler in right of his wife, and the administrator of M^{rs} E. Harris, and half-shares to Edward Harris, the heirs of Robert T. Musgrave and Mary C. Parris in right of her mother, and report to Court in order to a final decree.

In Chancery

This day this cause was debated by leave of Court and consent of parties and came on to be heard in the bill and answer and was argued by counsel. On consideration whereof the Court doth order adjournage and decree that Nathaniel Warren, Samuel Warham Jr. and John D. Parker be appointed Commissioners any two of whom may act, that they after advertising the time and place of sale for twenty days, sell to the highest bidder at public auction the lands whereof William L. Rockelle dec'd died, seized and possessed which were allotted by a decree of the Court to the heirs of a Nathaniel Rockelle as their proportion of said lands in the County of Southampton upon a credit of months, except for so much of the purchase money as may be necessary to pay the costs of this decree which they are directed to receive on the day of sale, that they take of the purchaser four bonds of equal amounts with good personal security, and assign one of said bonds to each of the heirs of Nathaniel Rockelle who have obtained their Land's app. in their own rights, and assign the others to the legally qualified guardians of the infants respectively, and report their proceedings to the Court in order to a final decree.

The Commissioners appointed to let the repairs of the Clerk's Office of this County made their report which is in these words "To the Worshipful Court of Southampton County. Jones has executed and completed the same according to contract and undertaking entered into with us the Commissioners who have examined and received the same 40 Witness our hands this 15th day of October 1840. all which is respectfully submitted to the Hon^{ble} Judge
