Jourdont and known as the Tavern lot lately kept by Charles Jones and the household and
kitchen furniture belonging to the same was acknowledged in the Clerk's Office on the 22^d
December 1840 by the said Thomas G Jones and together with the certificate annexed of the
jury examination and acknowledgment of the same admitted to Record.

Deed of Release from Editha R Edwards of the first part William J Schell Jr of the second
part and Thomas G Jones of the third part releasing certain lots and parcels of land situate
in the Town of Jourdont, Viz, parts of lots No 17, 18 & 19 was acknowledged in the Clerk's
Office on the 22^d December 1840 by the parties thereto and admitted to Record.

Deed of Release from James J French to Samuel Wallace releasing a tract of 105 acres of land
was acknowledged in the Clerk's Office on the 23^d December 1840 by the said James J French &
admitted to record.

Deed of trust between Samuel Wallace of the first part J R Edwards of the second part
and James J French of the third part conveying 105 acres of land was acknowledged in
the Clerk's Office on the 23^d December 1840 by the parties thereto and admitted to record.
An agreement between John Cooper and Sam Waller by which the said Waller covenants
to support the said Cooper during his life and was proved in the Clerk's Office on the 24th
December 1840.

Deed of trust between Anthony A Williams & John A Turner of the first part Samuel J
Douglas of the second part and Samuel J Harris and others of the third part conveying the in-
terests, Mary Gethergood belonging to the said Anthony A Williams and those who bear
therein. And the property of John A Turner was acknowledged in the Clerk's Office on
the 28th December 1840 by those of the parties thereto and admitted to Record.

Deed of Bargain and Sale from Thomas G Jones and Martha his wife to James B
Schell conveying one acre of land was acknowledged in the Clerk's Office on the 28th December
1840 by the said Thomas G Jones & admitted to record.

Deed of Bargain and Sale from Thomas G Jones and Martha his wife to Editha S Mahon
conveying a certain part of a certain lot in the Town of Jourdont designated at Lot No 10
also another lot & piece of land adjoining the same was acknowledged in the Clerk's Office
the 2^d January 1841 by Thomas G Jones and together with the certificate of the jury
examination and acknowledgment of the same admitted to Record.

Deed of Trust between Anthony A Williams & John A Turner of the first part J R
Edwards of the second part and Thomas G Jones of the third part conveying a certain
lot and piece of land situate in and adjacent to the Town of Jourdont & the balance
and the balance of the household and kitchen furniture belonging to the said lot and
was acknowledged in the Clerk's Office on the 11th day of January 1841 by the parties thereto
and admitted to Record.
