Yet upon this condition that if the said Bowry Biddle shall refuse and leave the jurisdiction of the Court made against him then the above obligation to remain or else to remain in full force and virtue.

Council by his Counsel fully heard. The Court after hearing the testimony and from all the circumstances of the case are of opinion and do therefore order that the said Joseph G. Council paid security for keeping the peace for the term of twelve months from this day that is to say the said Council to be bound in a recognizance in the sum of three hundred dollars with two securities in the sum of One hundred and fifty dollars each and that the said Council also pay the costs of this prosecution. Whereupon the said Joseph G. Council with James M. Council and John P. Doykin his securities here in Court severally acknowledged themselves indebted unto John Rutherford Esq^r Lieutenant Governor acting as Governor of the Commonwealth that is to say the said Joseph G. Council in the sum of three hundred dollars and the said James M. Council and John P. Doykin in the sum of One hundred and fifty dollars, of their respective goods and Chattels lands and Tenements lands and to the said Acting Governor and his Successors in the Office of Governor to the use of the Commonwealth hundred. Yet upon this condition that if the said Joseph G. Council shall keep the peace and be of good behavior towards the Commonwealth and all its citizens more especially towards the said Patrick Doles for the term of twelve months from this day then this recognizance to be void.
