"In conformity to the aforesaid order, we the undersigned Commissioners do hereby certify that we have runed the ground on which it is proposed to open a new road say from the Ding Ridge road near Benjamin Griffin to the Quaker road at Zachariah Turner, and have come to the conclusion that a road opened through the road proposed will be of great benefit, not only to the people in the immediate neighborhood, but to those living at a considerable distance, and in consequence of this belief, the neighbors have assembled together day after day and worked until they have opened and put in good repair the road as proposed in the aforesaid order, and we further report that it is the wish of the people generally that Eli Turner should be the surveyor of this new road, and that Nathaniel Turner should be the surveyor of that part of the Quaker Road that Eli Turner is now the surveyor of, and that the hands of Benj. Griffin, Jeremiah Snyder, Eli Turner, John Camp, Cary Norrell & John Harris be put to work on the new road, which will take the hands off the old road in an equal proportion, and we now ask the Court to adopt the new Road as public highway agreeable to the above report. Given under our hands this 10th day of October 1842, Benj. Griffin, Eli Turner, John Edwards" Commissioners. Whereupon the Court upon consideration of the said report did adopt and establish the said new road as a public highway.

Eli Snyder is appointed surveyor of the road road commencing near Capt Benjamin Griffin and running near Zachariah Turner and it is ordered that the hands of Benj. Griffin, Jeremiah Snyder, Eli Snyder, John Camp, Cary Norrell and John Harris do work thereon.
