Deal of bargain and sale from Edwin Raughton & wife to William Scaggs conveying land was acknowledged in the Office the 21st day of August 1843 by Edwin Raughton a party thereto and together with the certificate of the jury examination and acknowledgement of the wife admitted to Record.
