Kingson of the second part and P. J. Drury & others of the third part Conveying Negro  
slaves & other personal property was acknowledged in the office and admitted to Record

Conveying land was acknowledged in the office and admitted to Record

Deed of Trust between William J. Glou of the first part John W. Rockelle of the second  
part and John M. Gunley of the third part Conveying four foaled horses Cows & other  
personal property was acknowledged in the office and admitted to Record

part and Bennett Q. Carr of the third part Conveying land was acknowledged in the office

and James Hicks of the third part Conveying land Negroes Cows Hogs & other personal property  
was acknowledged in the office and admitted to Record
