The last will and testament of *Salome Bussard* dec^d was proved by the oath of *James Bussard* and *Richard J. Vick* two of the subscribing witnesses thereto and ordered to be recorded and on the motion of *David Bussard* the executor therein named who made oath and together with *Benjamin J. Bussard* and *David Boggard* his bondsmen entered into and acknowledged a bond in the penalty of two thousand dollars conditioned as the law directs to be paid to the Court for allowing a probate of the said will in due form.

Ordered that *Robert L. Barnes*, *Richard J. Dandow*, *Thomas H. Howell* and *John C. Dials* or any three of them being first duly sworn before a Justice of the Peace for that purpose do appraise all the personal estate of *Salome Bussard* dec^d and return the appraisement under their hands to Court.

Stephenson* with *Allen Stephenson* and *James M. Sullivan* his bondsmen entered into and acknowledged a bond in the penalty of two thousand dollars conditioned according to law.

The Court doth assign *Allen Stephenson* guardian to *Olymbeth B. Summerville* orphan of *Levi B. Summerville* dec^d and thereupon the said *Allen Stephenson* together with *James Sullivan* and *Alfred T. Stephenson* his bondsmen entered into and acknowledged a bond in the penalty of two thousand dollars conditioned according to law.

The last will and testament and codicil thereto annexed of *Benjamin Buffin* dec^d was proved by the oath of *Cephalus Darns*, *Edwin Bradshaw* and *Wells Bradshaw* the subscribing witnesses thereto and ordered to be recorded and on the motion of *Robert B. Buffin* one of the executors therein named who made oath and together with *Edwards Dials* and *Wells Dials* his bondsmen entered into and acknowledged a bond in the penalty of two thousand dollars conditioned as the law directs to be paid to the Court for allowing a probate of the said will in due form, liberty being reserved for the three executors to be joined in the said probate when he thinks fit.

Ordered that *William Atkins*, *Allen Edwards* and *Edgar Jones* being first duly sworn before a Justice of the Peace for that purpose do appraise all the personal estate of *Benjamin Buffin* dec^d and return the appraisement under their hands to Court.
