security entered into and taken out of the bond in the penalty of four hundred dollars conditioned
according to law.

The Court being of opinion that the lands in this County ought to be partitioned with the same
order and that the County be divided into 19 parishes as follows.

Parish No 1 From Ashaway road up the great swamp to Croffords road, down said road to
Ashaway river and down the said river to the beginning.

" No 2 From the north side of the flat swamp from the old parish line down to the Indian
branch and up that to the Anglers swamp, up the same to Robins branch and up that
to the flat swamp and down the flat swamp.

" No 3 Bounded by the Meherrin River and the flat swamp and from the old parish line
to the flat swamp and down to Thomas Creek.

" No 4 Between Ashaway River, Camp bridge road, the three creeks and the Wolfcreek
road.

" No 5 All the lands lying east of the Buchanan swamp, Ashaway River the Indian
law and the main road sometimes called the Creek road.

" No 6 From the Anglers swamp bridge, up the swamp to Townsends bridge, up the said
branch to the Anglers Chappell, then down Warrons road to the head of Buchanan,
down that to the new road and by the said road to the beginning.

" No 7 From the mouth of Rattles branch to the head of Georges branch down that to the
Rivers meadow, up that to Robins branch, up that to the head of the Anglers
swamp and down the said swamp to the beginning.

" No 8 From Robins branch up the south side of the three creeks to the County line to the
Meherrin river, down the said river to Thomas Creeks head and thence to Robins branch.

" No 9 From the former parish line down the flat swamp to Crofford road and along the
said road to the County line and up the said line to the Greenwell line, up that to the
old parish line and along the said line to the beginning.

" No 10 From Crofford road down the flat swamp to the County line to Crofford road
along the said road to the beginning.

" No 11 From the mouth of Blants swamp to the mouth of Ross swamp up that to
the Indian law down the said line to Crofford road up the said road to the
swamp and up the same to the beginning.

" No 12 From the parish line at the flat swamp down the said swamp to the mouth
of Blants swamp, up the same to the mouth of Ross swamp up that to the Indian law
along the said branch to Townsends branch, down that to the Anglers swamp and
that to the head of the Indian branch, down the said branch to the old parish line
to the beginning.
